## 3. Minutes of the previous meeting and matters arising.

The minutes of 28<sup>th</sup> May 2020 and 17<sup>th</sup> October 2019 were accepted as correct records of the meetings and no matters were arising not already covered by this agenda.

## 4. Review of committee structure

**Governors discussed the vacancy for a chair**. Janine Cresswell was proposed and seconded and elected unanimously. She will take up the position following this meeting and was thanked for accepting the post by other governors.

Governors wished to put on record their thanks to Alan Lowe for his outstanding work as outgoing chair. They appreciated the time and effort given to the school by him and his wife. Staff recognised the exceptional support he gave them.

**Action Point** - Miss Craig will inform parents of the vacancy for a parent governor in September.

Miss Craig was asked to update the website with terms of office for co-opted governors and minutes of FGB meetings. She explained that the website is currently being restructured.

# 6. Headteacher's report (previously circulated)

Miss Craig emphasised the following points in her report:

Ofsted – Writing is still an area of focus across the school

The target for attendance in 20/21 is 96%

Governors' attention was drawn to the SENCO report

Sports premium – The school has recently been informed that this will continue in 20/21. **Governors asked about the range of activities that this would support.** 

Miss Craig explained that the school will be using a range of modern sports to develop an active lifestyle for all pupils and parents will be encouraged to support their children in trying out new activities.

Classroom improvements were outlined

Policy review will take place in September

Attainment and progress data – Restrictions prevented formal assessments this term, but staff are committed to raising attainment across the school. **Governors asked if pupils will be assessed at the start of the Autumn term and were told that all staff carry out baseline assessments and gaps will then be filled including the gap in PSHE provision.** 

Action plans for each year group were outlined

The vison and ethos statements will be reviewed and updated in September 2020.

Governors expressed their thanks to Miss Craig for such a thorough report and appreciated the way the head and staff are keeping the school moving forward.
